construction industry to 2010 and beyond.

She stated that we achieved an important milestone earlier this year with the signing of the Construction Charter by the industry sectors and organizations represented at the conference.

She also stated that we must ensure that the Construction Charter is not merely reduced to a set of new rules governing procurement that the industry conveniently navigates but that the Charter should provide impetus for concrete shared action.

Minister Didiza reiterated that our overriding task is to expand the role of the construction industry in South Africa's Accelerated and Shared Growth Initiative (AGISA) aimed at halving poverty and unemployment by 2014.

She noted that construction is central to this and must create and maintain the infrastructure needed for shared economic growth and a better life for all people.

It is in this context that the government has reasserted its commitment to an infrastructure programme, which has effectively doubled public sector investment over the past five years. Cont...

of Consulting Engineers (SAACE) and the South African Federation of Civil **Engineering Contractors** (SAFCEC), were once again tasked by the Construction Charter Group to organize the second Construction Conference. A number of high profile speakers gave presentations at the conference dealing with unification, the Charter's role in transformation, gender issues within the industry, skills development as well as the first steps leading to the formation of

#### 'Construction South Africa'

Representatives of the 13 industry organizations at the conference were given the opportunity to present statements in support of Construction SA to the conference. Cooperation between all industry stakeholders is critical in view of the unique challenges that the industry faces, including the R372 billion that needs to be spent on infrastructure development over the next 3 years coupled with the current skills shortage in the industry. The formation of Construction South Africa and the future signing of an MOU between these business industry organizations will create a vehicle for combined membership of Business Unity South Africa (BUSA) and in turn give the industry a voice to influence government policy through NEDLAC.

The conference was divided into 4 seaments with the first segment facilitated by Glenville Cullum, President of SAFCEC. Pepi Silinga, Chairman of the Construction **Industry Development Board** (CIDB) kicked off the first segment on 'Unification and Charter' with a the presentation on the role of the CIDB in growth, development and transformation. This was followed by statements in support of Construction SA by industry bodies and was chaired by Bryan Westcott, Convenor of Interim Construction SA. Aubrey Tshalata, General Secretary of NAFBI and Mike Wylie, Joint Chair of the Interim Management Committee of Construction **Transformation Charter Group** 

followed this with a joint presentation on the Charter's role in unifying and transforming the industry. Fay Mukaddam, Board Member of SAWIC ended the session with a presentation on sector unity and gender issues.

The second segment dealt with Accelerated Growth. facilitated by Paul Kgole, President of SABTACO. Dennis Dykes, Chief Economist at Nedbank's Group Economic Unit got the session off to an interesting start with his presentation giving an overview of the economy with particular reference to factors impinging on the construction industry. This was followed by a presentation by Andrew Donaldson, Deputy Director-General of the National Treasury who presented the medium term budget framework with implications for the construction sector. Vuyi Hlabangane of ABSA Capital ended the session with a presentation on financing of infrastructure.


The third segment dealt with Development and was facilitated by Tshepiso Raletsemo, Chairman of Woman for Housing. Jerry Vilakazi, CEO of Business Unity South Africa (BUSA) started the session with a presentation on the importance of unity in the business sector.

This was followed by a presentation on urban design and why cities grow and how to plan properly presented by Mike Sutcliff, City Manager of eThekwini Metro. Phumelele Siphayi, National Chairperson of SAWIC ended the session with a review of the day. The Mayor of Durban, Obed Mlaba addressed the conference at the gala dinner.

The fourth session, held on day 2 of the conference was facilitated by Mandla Ndlovu, President of NAFCOC Construction.

#### **CONSTRUCTION INDUSTRY CHARTER**

The first important step in getting the Construction Charter Scorecard operational.

The IMC EXCO has finalised a notice for circulation to members and their clients that will provide greater clarity on the process of implementation of the Construction Industry Charter. This is presented in the form of a covering letter to "Circular No 1" and a "Circular No 1" document. The latter serves as a Guideline for the implementation of the Charter and Scorecard relating to the latest version of the Charter - Version 6.

Members are encouraged to circulate the letter to relevant clients notifying them that a copies of the documents are available for downloading at www.saace.co.za. Though certain clients might receive more than one invitation to obtain the document it will serve as positive reinforcement. There is also a proforma letter to suppliers in the circular, which companies can also use to notify their suppliers.

## ECTV Makes CPD Accreditation Easy

The final broadcast of Engineers in Practice 2006 was aired on DSTV on Wednesday night, the 1st of November.

1.A total of 814 engineering professionals participated in this training programme during 2006 and each of these professionals has attained a compulsory credit in category 1 of ECSA's CPD policy.

Some of these professionals who attended the Construction Conference and participated in the SAACE AGM, are now in the enviable position of having attained a

further category 1 credit as well as a category 3 credit, giving them a total of three credits for developmental activities. Add to this the additional 2 credits they can be awarded for work based activities in Category 2 and they have now attained their five credits for 2006!

This shows just how easy and uncomplicated it is to be compliant with ECSA's CPD policy. Johan van Schalkwyk, Manager of the Association's School of Consulting Engineering commented that, "The Construction Conference

was the first time that cell phone sms technology was used to electronically register CPD points and it worked very effectively". Van Schalkwyk noted that, "There is also a concerted effort from ECSA to ensure that the process works with their renewed commitment to the industry".

The success of the 'Engineers in Practice' series has prompted SAACE to continue with the programme in 2007. The first programme in the new series will be broadcast on the 7th of February 2007. A survey will

shortly be carried out to establish whether or not subscribers prefer the joint broadcast and DVD channels or whether they have a preference for one or the other. This will inform any changes to the method of distribution for 2007.

If you did not participate in the 2006 you can still order the set of ten DVDs at a cost of R1200 excl VAT, postage and packaging. The new 2007 series will now count towards category one credits, and therefore the 2006 programme will move to category 3 for 2007.

## FIDIC To Lobby For QBS

Arthur Taute, CEO of Vela VKE and Chairman of the Supply Chain Management Committee recently attended the International Federation of Consulting Engineers (FIDIC) Conference held in Budapest, Hungary. While at the conference he attended a workshop on procurement and stated that, "The Canadians blew us away with their well thought out presentation on Quality Based Selection (QBS) in préference to Quality and Cost based Selection (QCBS)".

Gian Cassartelli from the World Bank in charge of procurement of consulting engineering services, has also come to the conclusion, after many years of procurement

management, that QBS has a lot of merit and is believed to be busy working on trying to change the World Bank procurement systems in favour of QBS over QCBS. Dilek Macit of European Bank of Reconstruction and Development was also one of the keynote speakers and she is generally well respected and runs a very good ship in respect of procurement. They use QCBS for everything over E200 000. When asked what they did about ensuring that the technical scores and financial scores were at least in similar ranges so that price was not the ultimate determinant in the final award she said that they always include the budget for the service in the Terms of Reference and in this way ensure that prices are in a narrower band. In particular, if the scope of work is fuzzy, such as in preliminary design projects, this seems to be essential. One of the problems of QCBS is that technical scores are often in a narrow range - say 20 while financial scores can be in a wide range say 50 – then even if technical is supposed to count 70% and price 30% the difference in the ranges makes the price dominate no matter how much weight one gives the technical score. The FIDIC conference concluded that all of FIDIC and its member associations would lobby actively for QBS in future. Arthur Taute cautions that we must take care that

while the rest of the world is slowly moving towards QBS, we do not get caught in the trap of throwing out our old tried and tested systems (that created the best infrastructure in Africa) and replace them with procurement practices that have been shown to produce some poor results and are being retired by others.

It was generally acknowledged that the need for an informed client was paramount in all procurement!

## FIDIC / Budapest, Hungary

During the last week of September I attended the International Federation of Consulting Engineers (FIDIC) Conference in Budapest, Hungary. In my opinion this was one of the most successful and informative FIDIC conferences that I have attended. The conference had the theme 'Where the Roads Meet', and included a number of excellent presentations dealing with industry issues looking at the local, regional and global status of consulting engineers. Speed of change is the major challenge of the 21st Century, according to Professor Flanagan, in a keynote speech delivered to the conference. Over 550 professionals of the engineering and consulting industry from 66 countries discussed challenges, trends and opportunities. Good practices were defined as the crucial themes of the industry today, including quality selection, risk management and project financing. These are the major issues currently being addressed by the European (EFCA) and international federations (FIDIC) respectively. The message from the conference was that the consulting engineer must become the trusted advisor of the client. EFCA president Yann Leblais called o n professionals to think beyond the purely technical to the strategic and economic aspects of their job. Human their job. resources are the key to success. An international trend is that the fastest growing consulting firms are those that find innovative ways to fill the skills gap and choose new forms of partnerships and outsourcing. Consulting Engineers need to be proud of their profession as they increasingly provide a major role in advising the client to assess and manage risk, and fees should reflect the quality and innovative service being delivered.

A number of workshops were held dealing with project implementation, procurement best practice and emerging issues facing the industry at large. Of particular interest were topics related to the consulting engineering firm of tomorrow where there were debates around what the average consulting engineering firm would look like in 2020. In depth discussions were held relating to the new mechanisms for project delivery; developing and using the skills of design professionals; as well as business opportunities in new markets. At a more detailed level seminars were held on the FIDIC Design - Build - Operate contract, quality

procurement and risk responsibilities in infrastructure development.

I believe that the reason that this conference was different and had more impact than in previous years was in part due to the improved business opportunities in most countries, as well as the fact that Consulting Engineers are becoming much more aggressive in defining their role in the marketplace. Business models need to change and the traditional approach to consulting

engineering has become highly inappropriate.

While diversification in looking for new business opportunities does obviously involve exploring new markets in the sense of geographic diversity and including a wider range of disciplines in the business portfolios, it has become far more important for

consulting engineers to move up the value chain and begin to operate like management consultants.

It is important for consulting engineers to hone and develop their skills to way beyond the technical, to position themselves at the top of the food chain and become more proactive and entrepreneurial and



sensitive to clients needs. Consulting Engineers are superb at portraying the bad news but never shout about their successes and certainly do not like to talk about profitability. However, profit has been too low for too long, design has become cheap and there is a need for the industry to move away from being perceived merely as a commodity, but rather as a value added service to the client. It seems that the internal dynamic is for firms to get larger in order to handle ever increasing complexity and size of projects and this is becoming more prevalent. Not only is the business model changing,

but different ways of contracting, dictating whole life involvement through Public Private Partnerships (PPP's) and Private Finance Initiatives (PFI's) are on the increase requiring a greater awareness of the risk and reward dynamic. Although firms are getting larger, independent consulting engineer will always have a role as the delegates at FIDIC believe that 'Independence is a marketable commodity'. The message from the conference is clear that the industry must stop responding to market change and take the lead.

The conference highlighted the importance of soft skills and noted that human resources is becoming a critical factor. A clear message came through that it is critical to ensure that quality is not overridden by cost and that quality must become the key factor in our National Procurement processes. The Canadian association had achieved a high degree of success in this regard.

South Africa was prominent in the Young Professionals (YPF) programme, with the Association's young engineer of the year, David Freeme ably supported by last year's winner, Khelane Ndwandwe.

The Group of Africa Member Association's (GAMA) meeting also held at the conference was also very productive with the adoption and approval of new constitution allowing it to become a more effective regional body representing the views and needs of Africa. The newly adopted constitution will be formalized at the next AGMGAMA and conference to be held from the 14 May next year in Gaborone.


## Branch Of The Year
